2022 Air Conditioning Safety Inspection Form

An annual safety inspection is required for all central and window air conditioners, regardless of the age of the unit. This form must be used for the safety inspection. A separate form must be used for each A/C unit.

A technician from a licensed and insured air conditioner service company must perform the inspection. The safety inspection is separate from your annual service, however, it can be performed concurrently with your annual maintenance service. Additional forms can be obtained from the Receiving Room if required. The inspection must be completed by <u>June 30th 2022.</u>

The safety inspection form must be submitted directly to the Receiving Room by the A/C service technician prior to exiting the building following the inspection. The form will not be accepted if submitted by the shareholder.
